

October 27th, 2025 Special Town Board Meeting

At the Greenfield Town Hall a Special Meeting of the Greenfield Town Board was held October 27th, 2025 at 5:00pm with the following members present: Kevin Veitch, Supervisor, Mike Gyarmathy, Ty Stacey and Rick Capasso Councilpersons. Also present was Deputy Highway Superintendent Chris Stanton and approximately 15 residents. Absent was Councilperson MaryAnn Johnson.

Supervisor Veitch asked the Town Board if they had any questions, concerns or anything to say about the Budget. We did have several residents who are trying to understand the budget and had questions so the Town Board answered their questions for them. Everyone from the Town Board was happy with the Budget except Councilman Gyarmathy. Gyarmathy, C feels that all the information that was received or provided to him he is not certain that it is accurate. Also, he feels that the Town Board is inserting a rather large number \$826,737.05 from the fund balance to balance the budget and that number is way too high.

FURTHER RESOLVED, that the Town Clerk give notice of such Public Hearing in the manner provided in section 113 of Town Law and that such Notice be published in the following form:

NOTICE is hereby given that the preliminary Budget of the Town of Greenfield for the fiscal year beginning January 1st, 2026 has been completed and filed in the office of the Town Clerk, Town Hall, Greenfield Center, NY, where it is available for inspection by any interested person at all reasonable hours.

FURTHER NOTICE is hereby given that the Town Board of the Town of Greenfield will meet and hold a public hearing thereon, at the Town Hall, Greenfield Center, NY at 7PM on the 6th day of November, 2025 and at the Public hearing any person may be heard for or against the preliminary budget as compiled, or for or against any item or items as therein contained.

PURSUANT to Section 113 of Town Law, the proposed salaries of the following Town Officers are hereby specified as follows: Supervisor - \$31,231.74; Councilpersons (4) each - \$10,270.26; Town Clerk - \$68,416.21; Town Justices (2) each - \$20,625.31 and Superintendent of Highways - \$75,000.00
